- The recipient shows signs of intoxication.

**STATE TAX & SHIPPING INFORMATION**

- Orders cannot be shipped the same day they are placed.
- Shipping wine is complicated by various state-mandated limits and requirements. We run your order through our state compliance matrix to ensure a legal shipment. It takes one business days to process the order, check it, and then send on to picking and packing.
- If you would like to schedule an order with a shipping date further in the future than the regular schedule, please give us a call at 503-713-3277. We are happy to schedule orders for future ship dates pending inventory availability.
- We ship only Monday through Wednesday as various states heat up to minimize the likelihood that FedEx or UPS will have possession of your wine over a weekend in their warehouse. Not all warehouse are temperature-controlled.
